<b>2021 COVID-19 Fee Support Program</b>	
Job Seeker	Parents/carers in receipt of Job Seeker are eligible for a reduction of up to 100% of their child's Education Fee for Terms 1 to 3. Payments on the balance of fees will commence from Term 4, 2021.
Job Keeper	Parents/carers in receipt of Job Keeper with a reduction to their income are eligible for a reduction of up to 50% on their child's Education Fee for Term 1. Payments on the balance of fees will commence from Term 2, 2021.
